Modified CV - List and describe 4 or 5 products (publications, awards, grants, etc) indicating the significance within the nominee's career

Section 4: Letter of Support

2-page maximum

Include a signed letter of support which outlines the significance of the nominee's research program and publications.

The individual submitting a letter of support must be familiar with the nominee's academic contributions and accomplishments.

The letter cannot be from the nominee's MA or PhD supervisor.

It is the responsibility of the nominator to request a letter of support and ensure that it is submitted by the deadline.
